

Is your facility accredited for Medicare Part B? If not...it may be too late!

Accreditation deadline is September 30, 2009 for suppliers of durable medical equipment, prosthetics, orthotics and supplies, who bill Medicare Part B. Suppliers must obtain accreditation by September 30, 2009 or their Medicare Part B billing privileges will be revoked. These accreditation requirements apply to suppliers of durable medical equipment, medical supplies, home dialysis supplies and equipment, therapeutic shoes, parenteral/enteral nutrition, transfusion medicine, prosthetic devices, and orthotics.

The University of Pittsburgh School of Pharmacy is proud to be partnering with BLACKBURN'S Pharmacy to provide advanced training for a Community Pharmacy Resident and establishing a Medication Therapy Management (MTM) service. Medication-related problems are a significant public health issue in the United States. The inappropriate use of medications contribute to more than 1.5 million preventable, medication-related adverse events each year and account for an excess of \$177 billion in morbidity and mortality. 1

What is medication therapy management? Medication therapy management (MTM) service allows the patients to sit down with a pharmacist, one-to-one, to discuss and evaluate their medication-related needs. Patients can make an individual appointment with a pharmacist to review their entire medication regimen to help ensure the patient is getting the most of their medications to improve their health. MTM is separate from the dispensing of a drug product, as it occurs in a patient care room. The pharmacist will identify, prioritize, and resolve medication-related problems with the patient and their caregivers. The pharmacist will work with the patient's physician(s) to ensure the medications are the best and most effective for the patient.

Core services of Medication Therapy Management program


Medication Therapy Review: A systematic process of collecting patient-specific information, assessing medication therapies to identify medication-related problems, developing a prioritized list of medication-related problems and creating a plan to resolve them.

Personal Medication Records: A comprehensive record of the patient's medications (prescriptions and nonprescription medications, herbal products and other dietary supplements).

Medication-Related Action Plan: A patient-centric document containing a list of actions for the patient and their caregiver to use in tracking progress for self-management.

Intervention and/or Referral: Consulting services and pharmacist interventions to address medication-related problems. When necessary, the pharmacist refers the patient to a physician or other healthcare professional.

In July 2009, Shannon McLaughlin, PharmD, joined BLACKBURN'S Pharmacy staff as a Community Pharmacy Resident to work directly with patients to assist them in meeting their medication-related needs. A Community Pharmacy Resident is a licensed pharmacist who is interested in gaining more experience in caring for patients' medication-related needs, working directly with physicians and all health care practitioners, teaching and conducting practice-based research. Dr. McLaughlin will work with area physicians in establishing BLACKBURN'S MTM service.
