THE MEDICARE COMPETITIVE BIDDING COUNTDOWN CONTINUES

The plan to change the way Medicare provides beds, power wheelchairs, oxygen, c-pap, bi-pap, walkers, and other selected products to the elderly and disabled at home is in full swing at the Centers for Medicare and Medicaid Services (CMS). Median pricing (what providers will be paid) for specific categories of product will be announced in June. In September, the "winning" contractors will be announced. Then, January 1, 2011, the program will begin.

Initially affecting nine metropolitan statistical areas across the United States, including Pittsburgh, it will eventually apply to the entire nation...if not repealed. The problem with this program is it's anything but competitive!

Medicare plans to select a "chosen few" providers to service beneficiaries in each MSA based upon the lowest range of bids submitted. They can be out of the region, out of the state if their price is low enough. Transparency is not as clear as it should be either. Providers don't know how Medicare will determine if the one year of financial data is acceptable, are not sure how Medicare is determining if a bid is "suicide bidding" or too low, and ultimately worry bids submitted will not be sustainable for the mandatory three-year contract period.

HR3790, the House Bill to repeal the Competitive Bidding program is gaining strong momentum. As I write this, 227 House members have co-signed the Bill, reflecting a next-to-never seen bi-partisan majority in favor of dismantling the ill-conceived program.

In the Pittsburgh MSA, Congressmen Jason Altmire, John Murtha, Tim Murphy and Congresswoman Kathy Dahlkemper lent their early support by signing onto the measure. Our industry applauds these champions who recognize this is poor healthcare policy and has repeatedly touted the unintended consequences of competitive bidding.

BLACKBURN'S has tirelessly worked to get HR3790 passed! Just this week, the House Ways and Means Committee requested the Congressional Budget Office to score the bill. This indicates acknowledgement that the bill has gained wide bi-partisan support and it must be brought to the floor for discussion. Our industry is simultaneously working to secure a Senate Companion bill to mirror the House language and drive repeal into law prior to the inception date of January 1.

You can help! Contact your state representative and if not already done so, ask them to sign onto HR3790. Sincerely thank them if they have. Let Senators Specter and Casey know their support on the upcoming Senate Companion bill is needed and appreciated.

Competitive Bidding is akin to auctioning healthcare to the lowest bidder. Excellent patient care begins with dependable service from a quality community provider who services round the clock. Our elderly and disabled deserve better than Competitive Bidding.

BLACKBURN'S...APPROVED PROVIDER FOR PDA WAIVER PROGRAMS

The Pennsylvania Department of Aging Waiver (PDA Waiver) operates in select counties in Pennsylvania providing home and community-based services to persons aged 60 or older who require a level of nursing facility services, but who can appropriately be served in their own homes or in other community living arrangements.

The Office of Medical Assistance Programs has primary responsibility for the PDA Waiver and the Pennsylvania Department of Aging oversees the local Area Agencies on Aging (AAA) who are responsible for ensuring the delivery of services to eligible recipients by qualified providers.

ELIGIBILITY AND SERVICES

The local County Assistance Office (CAO) is responsible for determining medical assistance eligibility in accordance with the Non-Money Payment Medical Assistance category (NMP/MA) or the special income/resource limits in Waivers. The CAO will name a contact person and an alternate to exchange information and resolve problems with the local AAA.

PDA and the Office of Medical Assistance Programs (OMAP) are under agreement with qualified providers like BLACKBURN'S to provide the specific services covered under the PDA Waiver.

Approved providers such as BLACKBURN'S must be enrolled in the MA Program.
